

PERMISSION TO PARTICIPATE IN ACTIVITIES

PROGRAM PARTICIPATION: I authorize my child to fully participate in all program activities for which he/she has registered unless prior written notification has been given.

NATURE AND DURATION OF ACTIVITIES: Activities will involve tutoring sessions either one on one, in a small or large group, camp or class setting with virtually no physical activities involved. Twenty four hour notice must be given when cancelling a private or group session or charges will be assessed. Class and camp programs will not be prorated due to a child's unexpected absence.

ACTIVITY SUPERVISOR(S): Students will always be supervised by at least one adult (office staff) with a level 2 fingerprint and background check. Classes, camps and tutoring will be administered by an adult with a minimum of a Bachelors Degree in Education. In some cases teenage staff will assist the adults in a larger group environment. All adults working with students will have a complete Level 2 Background Clearance.

TRANSPORTATION: All About Achieving Learning Center will never transport any student for any reason.

REQUIREMENTS: The parent should notify All About Achieving Learning Centers of any medical concerns that may affect the student in any way. This includes allergies, disabilities, physical/mental limitations, as well as any other information needed (listed below) to insure the safety of the student and all other individuals involved.

CONSENT: I hereby consent to the above-named child's participation in the activities described above, and specifically request that he or she be allowed to participate in those activities. I understand that in some cases, live animals or food may be used in a program or class. My child has permission to fully participate in all activities related to these programs unless prior written notification has been provided by the parent.

INSURANCE: I understand that ALL ABOUT ACHIEVING LEARNING CENTERS, INC. does not carry any insurance relative to the activities or for any injury that may occur to the above-named child except for general liabilities and physical facility coverage. I represent that the child is covered by insurance through my own insurance carrier.

EMERGENCIES: If the above-named child requires any emergency medical procedures or treatments during the activities, I consent to the activity supervisor(s) taking, arranging for or consenting to such procedures or treatments at the discretion of the activity supervisor(s). AAALC will contact 911 and then the parent should an emergency occur. If in the event of a medical or other emergency, I am unable to be reached by telephone, I authorize the activity supervisor(s) to attempt to call the emergency contacts listed on my enrollment form.

RELEASE AND INDEMNIFICATION: I release and waive, and further agree to indemnify, hold harmless or reimburse ALL ABOUT ACHIEVING LEARNING CENTERS, INC the individual members, agents, employees and representatives thereof, as well as activity supervisors, from and against, any claim which I, any other parent or guardian, any sibling, the above-named child, or any other person, firm or corporation may have or claim to have, known or unknown, directly or indirectly, for any losses, damages or injuries arising out of, during, or in connection with the child's participation in the activities, the travel to and there from, and the rendering of emergency medical procedures or treatment, if any.

PHOTO/VIDEO RELEASE: Photographs or videos of the children participating in activities provided by the center may be taken and published for advertising purposes. Your child may be included in these releases unless you notify us in writing that you do not want your child's image published.

CANCELLATION: Students who are unable to attend class once registration is complete will be provided with a credit towards another service or a full refund less a 15% registration fee.

PLEASE NOTE: There is a \$25 cancellation fee for all cancellations that occur more than two weeks prior to camp. AAALC will not issue a refund for any camps cancelled within two weeks of the camp start date unless there is a waiting list. Space is very limited and AAALC wants to accommodate all interested budding scientists!
